SECTION 4: FIRST-AID MEASURES
4.1. Description of first aid measures
General information

If breathing is irregular, drowsiness, loss of consciousness or cramps: Call 911 and give immediate treatment (first aid).

SECTION 5: FIRE-FIGHTING MEASURES

SECTION 7: HANDLING AND STORAGE

7.1. Precautions for safe handling

It is recommended to install waste collection trays in order to prevent emissions to the waste water system and surrounding environment.

The product should be tested for peroxides before distillation or evaporation and tested for peroxide formation or discarded after 1 year.

Peroxide formation may be present anywhere in the container, including the sides, bottom, exterior and threaded cap.

Peroxide formation in ppm concentrations may not be visually observable and must be identified through the use of appropriate testing procedures. If any of the following conditions exist, the material may be explosively unstable and will require stabilization prior to use:
